




- On Tuesday, after a gap-up start, Nifty faced profit booking near 25,900, which dragged the index lower for most of the session. However, a late recovery helped trim losses, and Nifty finally settled negative with a loss of ~58 points.
- In the current Weekly Series, the OI concentration on the CALL side remains at 26000 Strike while for PUTs, at 25700 Strike.
- Weekly PCR has dropped to 0.66 from 0.87 earlier.
- FII's have increased their net Short exposure on Index Options by ~43K contracts, with the overall net position now standing at -315K.

Nifty Put-Call Ratio (OI)





FII Net Index Options OI






MAX PAIN PLOT





Top10 Futures Open Interest Gainers/Losers




Top10 Options Fresh Commitments
