

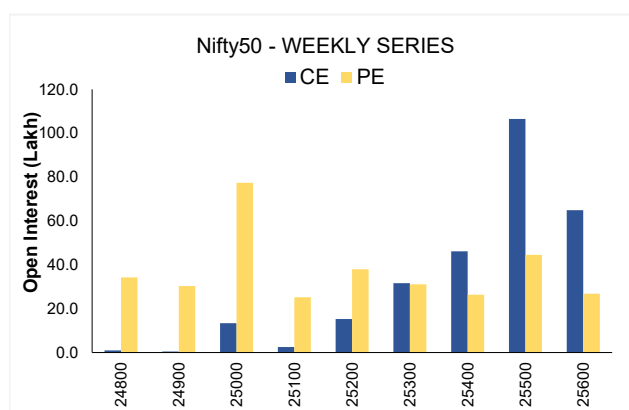

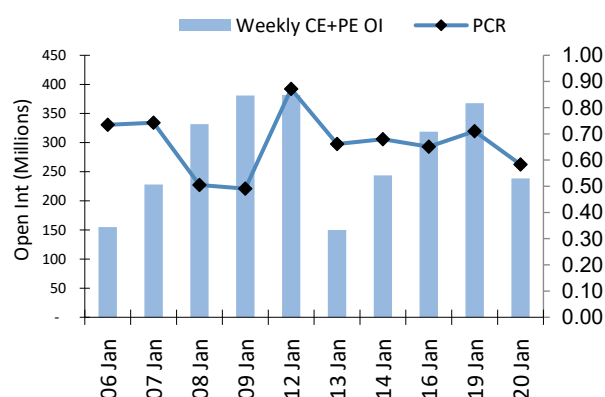
- On Tuesday, the selling further intensified pushing Nifty50 below 25,200 and finally closing the session with a notable cut of ~353 points.

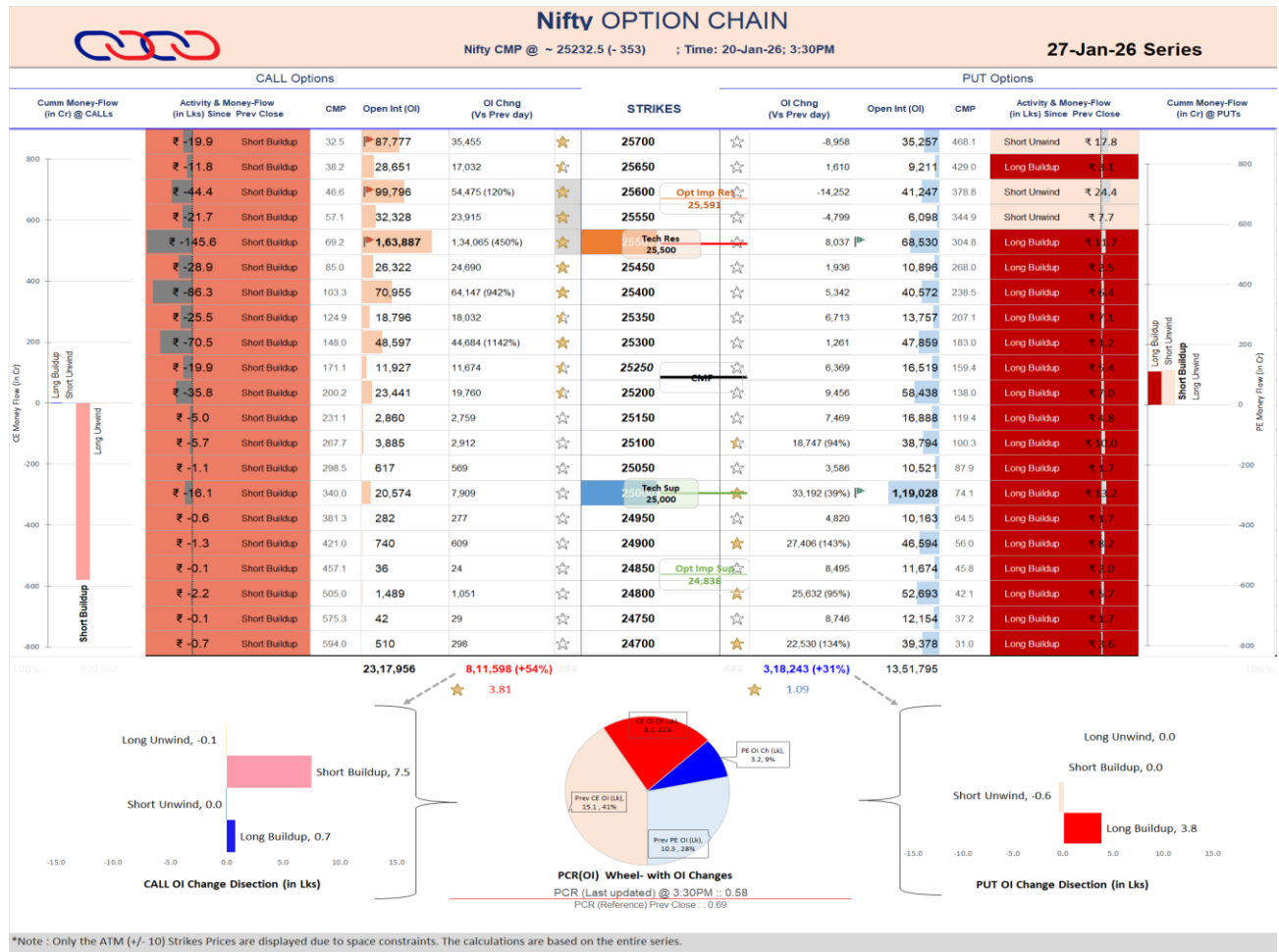

FII Net Index Options OI



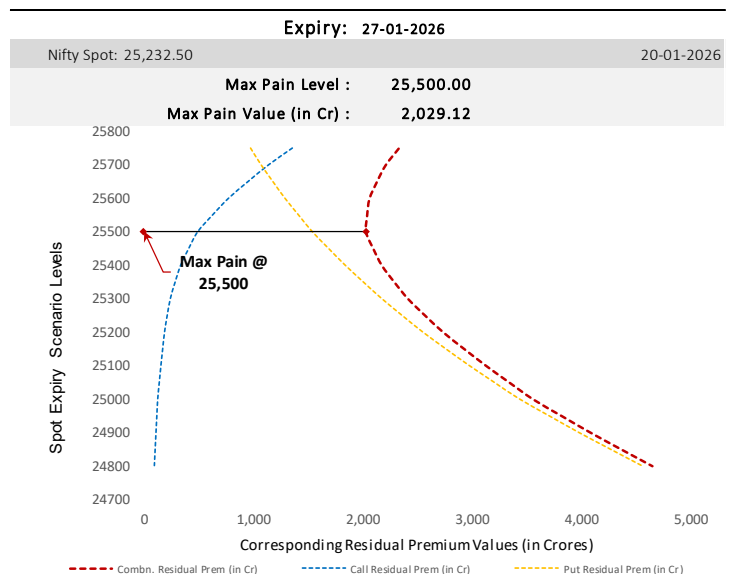

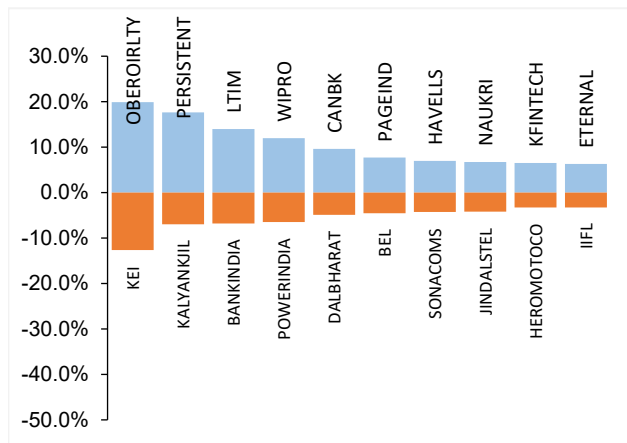
MAX PAIN PLOT



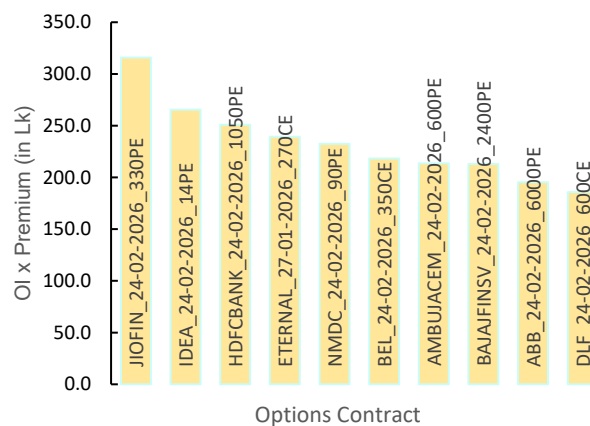

Top10 Futures Open Interest Gainers/Losers

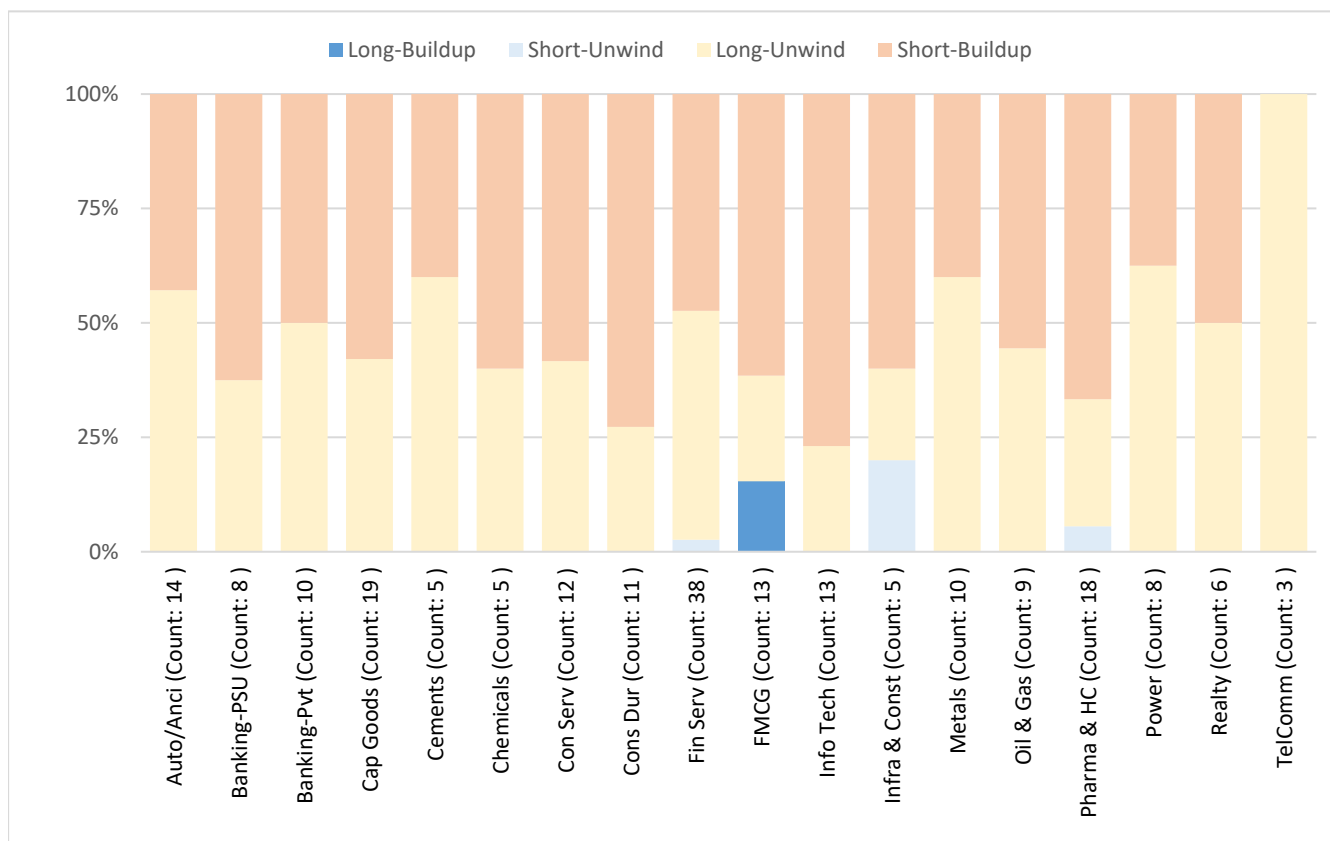


Top10 Options Fresh Commitments
