

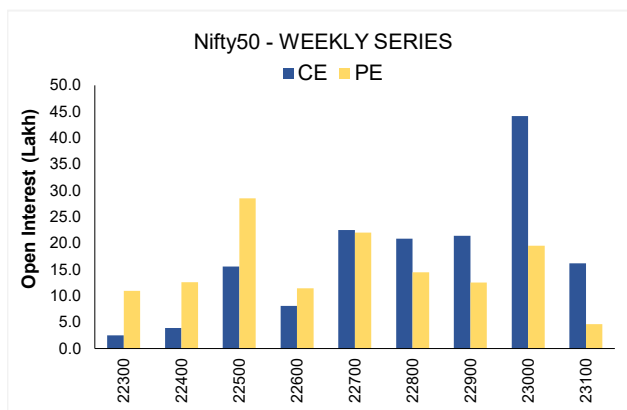

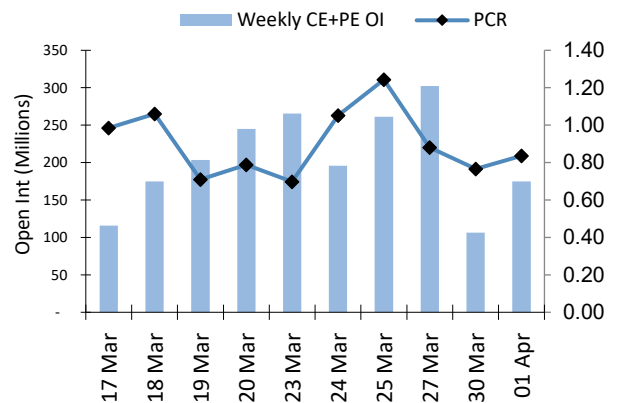
- On Wednesday, after a gap-up opening, Nifty witnessed profit booking around the 22,940. Following a volatile session, the index eventually settled near the day's low, still ending ~ 348 points up.
- In the current Series, the OI concentration on the CALL side is seen at 23,000CE Strike while for PUTs, it is at 22,500PE Strike
- Weekly PCR has moved to 0.84 from 0.77 earlier.
- FIIs have slightly increased their net Short exposure on Index Options by 15K with the overall net position now standing at -611K.

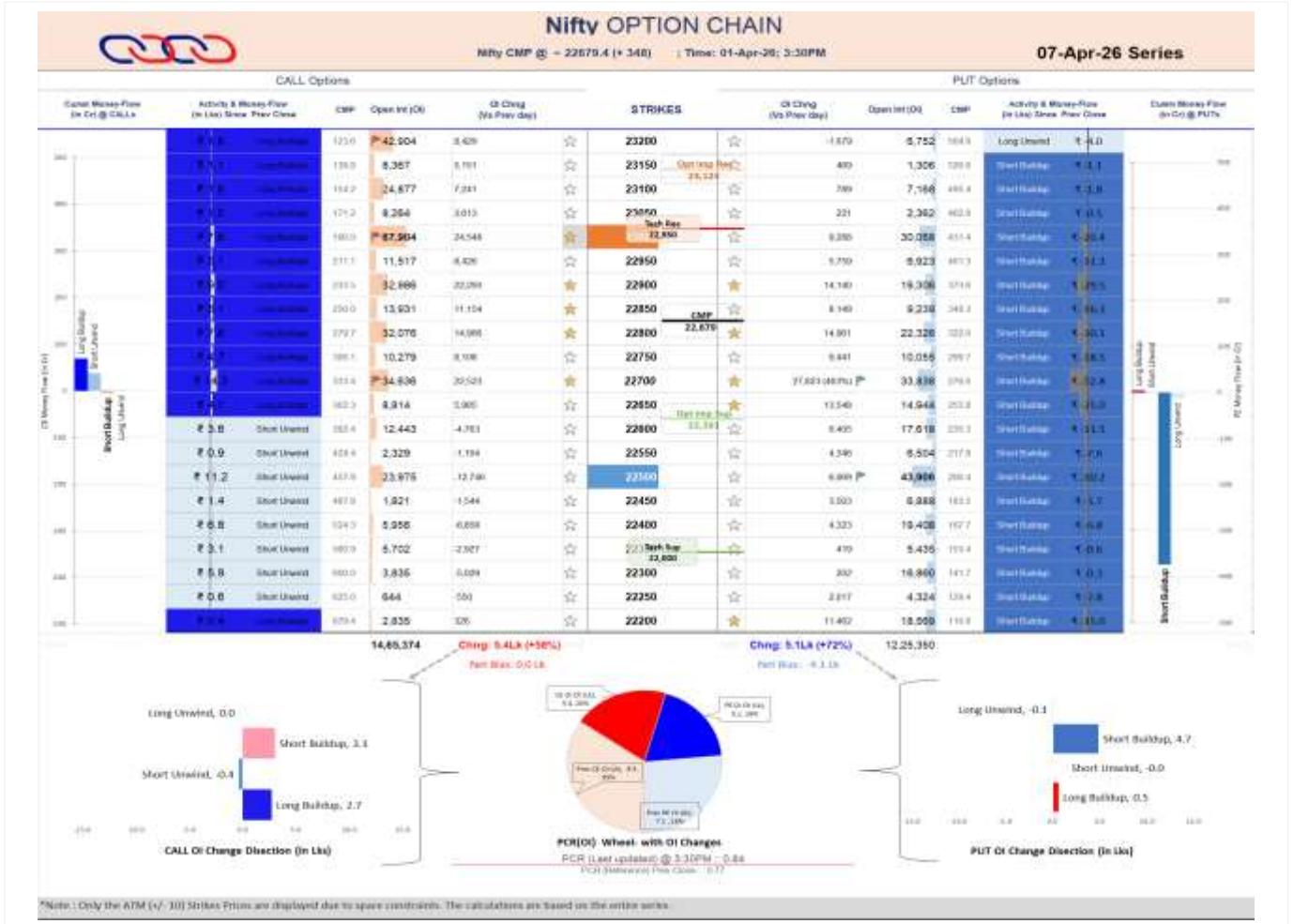

FII Net Index Options OI



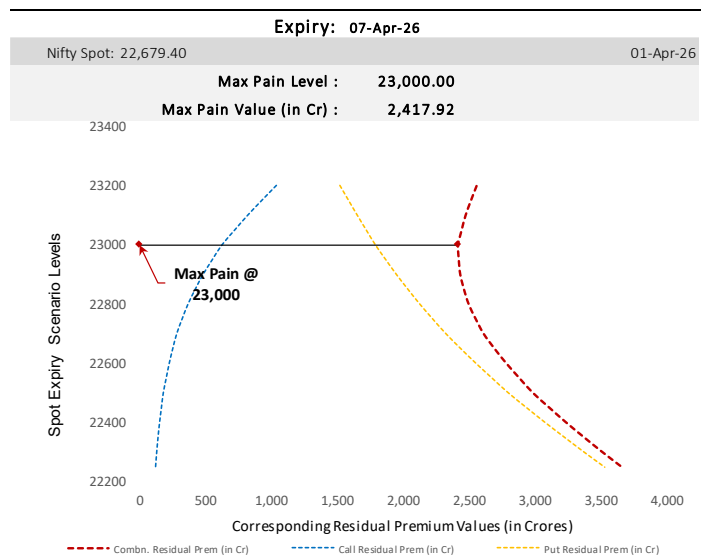

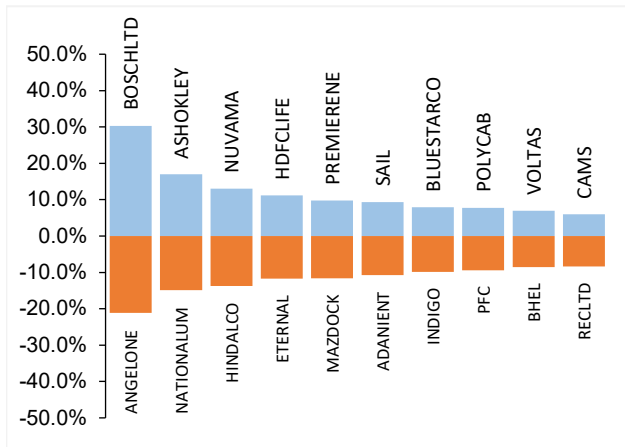

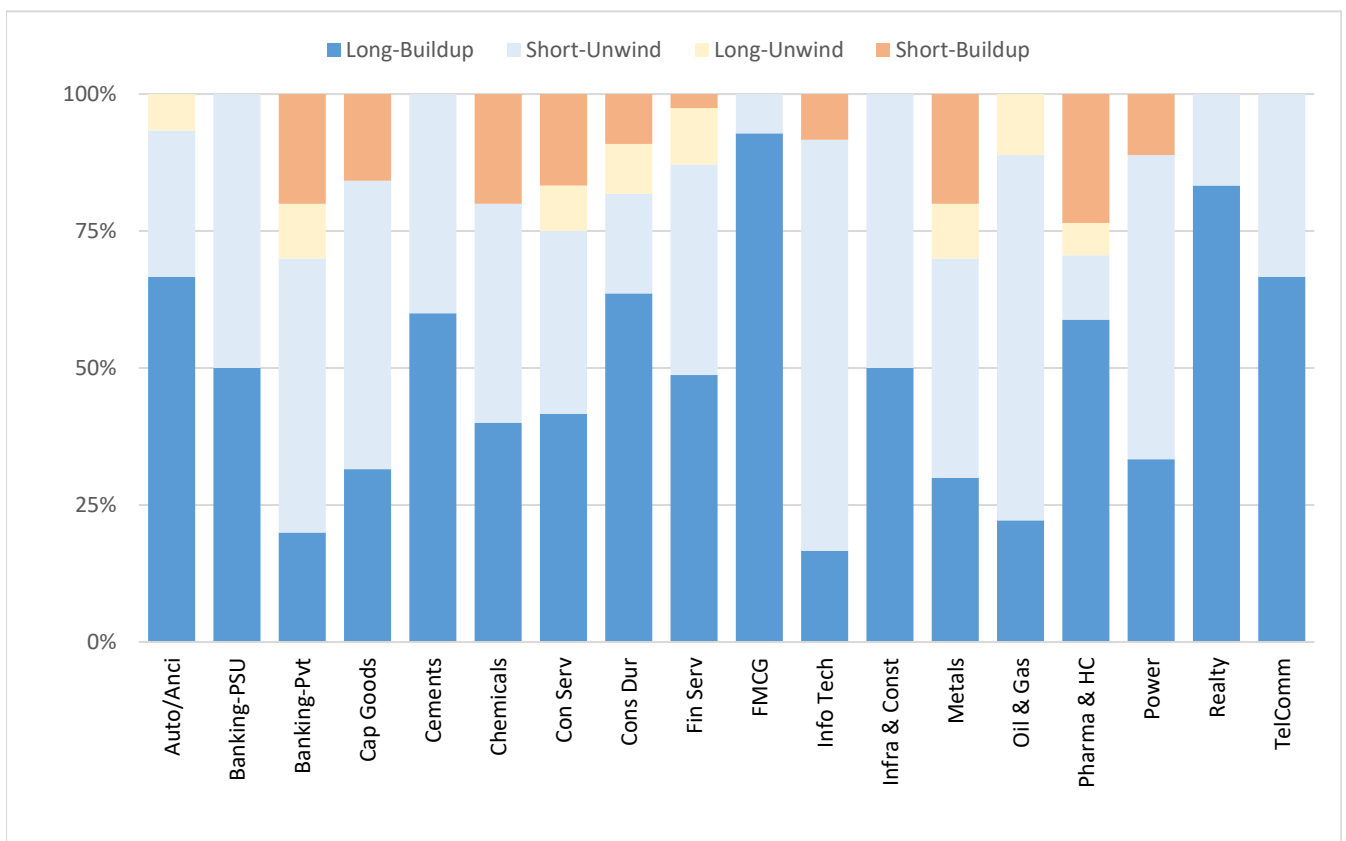
