
Bullion – Spot gold and silver advanced over 1% and 4% respectively on Wednesday as escalating US–Iran tensions lifted safe-haven demand, following reports that Washington may deploy a second carrier strike group if nuclear talks fail. Gold eased from an intraday high above \$5,115 to settle below \$5,085/Oz, while silver closed near \$84.3. Stronger-than-expected US January payrolls—130K versus 70K forecast—alongside a drop in unemployment to 4.3% and a 0.4% m/m rise in wages, tempered expectations of Fed easing. Markets now price the next 25 bps cut in July, not June. Today, gold eased toward \$5,050 after strong US employment data tempered expectations of near-term Fed rate cuts. However, ongoing geopolitical tensions, constant central bank purchases, and currency debasement concerns continue to support bullion. Markets now awaits today's jobless claims and Friday's US CPI for direction.

Crude Oil – WTI crude oil edged higher to \$65.8/bbl yesterday as markets monitored the US-Iran situation, with military options still on the table keeping geopolitical risk elevated in a key oil-producing region. However, prices retreated to settle at \$64.6/bbl after the EIA reported an 8.5 million barrel increase in US crude inventories to 428.8 million barrels, the highest level since June. Today, oil prices rebounded toward \$65/bbl as President Trump said no “definitive” agreement was reached with Israeli Prime Minister Netanyahu on Iran, but negotiations with Tehran will continue, keeping markets cautious as they assess the prospects of a nuclear deal. Besides, International Energy Agency's monthly outlook will also be closely watched.

Natural Gas – NYMEX gas futures held above \$3/mmBtu, supported by expectations of another sizable draw in US inventories, although milder weather projections limited further gains.

Base metals – Base metals on the LME ended on a firmer footing, with copper settling near \$13,166/ton while nickel outperformed, gaining over 2% on tighter supply expectations, after Indonesia signaled plans to curb output, tightening global supply conditions and providing additional support to t Copper held onto recent gains despite softer near-term demand signals from China, where industrial activity has slowed ahead of the Lunar New Year holidays. Prices continued to draw support from ongoing supply disruptions and resilient global demand. A weaker US dollar also lent support, even as stronger-than-expected US payroll data pushed market expectations for Federal Reserve rate cuts further out, reinforcing a cautious macro backdrop. While Chinese buying activity has moderated in the near term, investor sentiment remains constructive amid constrained mine supply and declining ore grades.
