This is further to the Exchange Notice No. 20260428-40 dated April 28, 2026, and the communication received from NPCI wherein it is stated that Paytm Payments Bank Limited has been disabled in NACH for any further transactions.

In view of the same, Members are hereby advised to note the following points:

- Bank account/s pertaining to Paytm Payments Bank Limited registered by Members for their clients in the Unique Client Code (UCC) shall stand invalidated.
- Mandates registered by Members for their clients with bank account details of Paytm Payments Bank Limited shall be rejected on the BSE StAR MF platform with remark: “RBI cancels the licence of Paytm Payments Bank Limited.”
- In case of all existing systematic registrations (including XSIPs) where Mandates associated with Paytm Payments Bank Limited are mapped, Members are advised to replace such mandates with mandates associated with bank account belonging to other banks with immediate effect.
- Paytm Payments Bank Limited as a bank shall cease to be available in the list of valid banks for use while new UCC creation and / or for fresh mandate registrations.

Members shall ensure that necessary changes are implemented at the earliest.
