Ratings Rationale

- Chola reported a Profit After Tax (“PAT”) of Rs. 1,155 crores in Q2 FY26, 3% below our estimates of Rs. 1,186.9 crores.
- Disbursement were weak across segments. Gross Non-Performing Loans (“GNPL”) was at 4.6% in Q2 FY26 from 4.3% in Q1 FY26 and 3.8% in Q4 FY25.
- Net Interest Income (“NII”) growth was in line at 25% yoy, and Asset Under Management (“AUM”) growth was 21% yoy.
- Chola’s smooth execution over the years has been impressive, but the current set of asset quality challenges has marred its near-term prospects for growth and the trajectory of credit costs.
- While we optimistically look forward to improving trends and GST cut benefits, overall risk-return has turned unfavourable, prompting to wait for better entry point.
- We revise our Fair Value to Rs. 1,600 and downgrade the rating on the stock to REDUCE (from ADD).
