Closing Price:

The term "closing price" shall refer to the price at which a particular security concludes trading on the immediately preceding trading day.

Trend:

The trend shall be defined as the prevailing level at which market participants are able to ascertain the general direction of price movement. A pronounced trend shall be interpreted as bullish market sentiment, whereas a weak trend shall be indicative of bearish sentiment.

Achievable (Supp/Resis):

This price level represents a potential intraday resistance or support point for the index or stock, contingent upon the trading activity exceeding or falling below the closing price. In general, day traders may regard this level as the initial zone of resistance or support during intraday trading.

Potential (Sup/Resist):

This constitutes the second designated support or resistance level, which may be attained when the stock or index is exhibiting a trending trend. External events or circumstances may influence the movement of the stock or index toward these levels.

Extreme levels:

Sometimes, securities or market indices may drop to very low levels or rise to very high levels that are beyond the usual daily fluctuations seen under normal market conditions. When this happens, it's important to be cautious if you are using trend-following trading strategies that rely on the current market direction within the same trading day. These extreme levels are viewed as important support and resistance points, which can be useful for analysing the market and making trading decisions
