

**Notification by the Government of India about Quality Control Order**

In terms of the provisions of the Rules, Bye-Laws and Regulations of the Multi Commodity Exchange Clearing Corporation Limited ("MCXCCCL"), the Members of MCXCCCL are notified as under:

The Ministry of Textiles has notified Cotton Bales (Quality Control) Amendment Order, 2023 on August 13, 2024. The notification attached herewith states that it will come into force from August 27, 2025.

MCXCCCL has accredited warehouses for storage and delivery of goods as required under contract specifications of Cotton Bales.

Accordingly, depositors who intend to deposit Cotton Bales at MCXCCCL accredited warehouses are informed that the warehouses will check the following additional points/documents over and above the existing procedure of deposit on implementation of the QCO:

1. Goods are required to bear Standard Mark under a license from Bureau of Indian Standards (BIS).
2. Goods or article specified in the attached notification shall conform to the corresponding Indian Standard specified therein.
3. The warehouse shall check the authenticity of document submitted by the depositor and verify the BIS license of the producer

**ORDER**

New Delhi, the 13th August, 2024

**S.O. 3469(E).**—In exercise of the powers conferred by sub-sections (1) and (2) of section 16 read with section 17 and sub-section (3) of section 25 of the Bureau of Indian Standards Act, 2016 (11 of 2016), the Central Government is of the opinion that it is necessary or expedient so to do in the public interest and after consulting the Bureau of Indian Standards, hereby makes the following order to amend the Cotton Bales (Quality Control) Order, 2023, namely:-

1. (1) This Order may be called the Cotton Bales (Quality Control) Amendment Order, 2023.  
(2) It shall come into force on the date of its publication in the Official Gazette.
2. In the Cotton Bales (Quality Control) Order, 2023, in paragraph 1, for sub-paragraph (2), the following subparagraph shall be substituted, namely: -  
“(2) It shall come into force on the 27th day of August, 2025.”.
